Do you feel like you are drowning in documentation? Are you spending more time writing and **rewriting** documentation for health insurers such as Medicare, Medicaid, Medicare Advantage Plans and Private Insurances than actually treating patients? Is this affecting your personal life because there is not enough time during the day to complete this documentation? If so please be aware this could lead to ethical and legal implications (violate the anti kickback statute) so just say no to that offer. There is a compliant way to give them what they want so qualified patient can receive the mobility equipment in a timely manner.

In this interactive workshop participants will gain insight into health insurance plans documentation requirements for mobility products and related accessories. The instructor, a former Director at Medicare, will share the internal thought process of health insurance plans which will enable therapists to provide them what they need in order to approve a claim for qualified patients.
